## Critical Difference Professional Development Grant Application

Deadline April 1, 2024

Grant may be used July 1, 2024 - December 31, 2024

***Funds must be used towards professional development expenses, such as conferences and workshops, equipment, research activities, certifications, licensure exams, etc.***

This grant is open to all employees who have been continuously employed at Ohio State for at least one year. Faculty and staff are eligible for grants up to \$1500.

The award is also open to full-time students at the sophomore (second-year) level and above, including graduate and professional students. Students may be granted awards up to \$1000. Students who will graduate in May 2024 are ineligible to apply.

***\*\*If you are seeking funding for an expense between Jan 1, 2025 and June 30, 2025, please wait and apply during the Fall Critical Difference Professional Development grant application period (due November 1, 2024).***
